The draft Plan reflects months of community input, expert advice, and careful review. It sets out a shared vision for how Little Hallingbury should grow, protect its rural character, and support community life. But before it moves to the next stage — independent examination — we need to hear from you.

Whether you agree with the Plan, have ideas for improvement, or want to raise concerns, your feedback will help ensure the final version truly represents our community's values.

#### **What Happens Next**

After the consultation closes, all feedback will be reviewed and used to refine the Plan. It will then be submitted to Uttlesford District Council for independent examination in spring 2026. If approved, the Plan will go to a parish-wide referendum — and a majority vote will make it official planning policy.
